CAUSE NO. 2 OF 1980

## Parties:

Kenya Management Staff Association  
and

Assia Pharmaceuticals Ltd.

## Issue in dispute:

Termination of services of Dr. R. K. Mutugi.

1. The Kenya Management Staff Association shall hereinafter be referred to as the claimants and Assia Pharmaceuticals Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 20th and 21st March, 1980 and in addition to relying on their written and verbal submissions the parties called the following witnesses to give evidence on oath:

Claimants.—Dr. R. K. Mutugi.

Respondents.—Mr. I. Wagiciengo.

## AWARD

3. The Minister for Labour signed the reference of this dispute to the Industrial Court on 12th January, 1980 in accordance with section 7A of the Trade Disputes Act. The court received the notification of dispute from the Minister with the relevant statutory certificates on 15th January.

Dr. R. K. Mutugi who is a veterinary doctor started working for the respondents from 1st February, 1977 at K.Sh. 4,500 p.m. as Manager (Veterinary Department). Prior to this Dr. Mutugi was in the Government service and was working as a district veterinary officer, Nairobi Area when he saw an advertisement for a job with the respondents for which he applied and was successful.

From June to December, 1976 the respondents and Dr. Mutugi corresponded and discussed his terms of employment with the final letter of appointment being issued on 23rd December, 1976 which was accepted and signed by Dr. Mutugi. The important parts of this letter of appointment are that his position was that of Manager (Veterinary Department) and it was stated in para 3 that he will not without prior consent of the respondents be employed in any way or for any purposes outside office hours by any person, firm or body other than the respondents. Further clauses 9 and 10 read as follows—

"9. You will be on probation for a period of six months from the date of commencement of your appointment after successful completion of which a letter of confirmation to the position to which you have been appointed will be issued to you. During probation either party may terminate this contract by a written notice of one week or one week's salary in lieu of notice.

10. After confirmation as aforesaid either party may terminate this contract by a written notice of three months which may expire on any day of the month, or three months' salary in lieu of notice."

The claimants took up the matter on behalf of Dr. Mutugi and reported a trade dispute to the Minister for Labour. An investigation was carried out and the Permanent Secretary, Ministry of Labour, forwarded the following findings and recommendation to the parties and suggested that this should form the basis for the settlement of the dispute—

"It is noted that Dr. Mutugi had completed his probationary period of six months and that during his probationary service he was not warned about any shortcomings either verbally or in writing.

The management's allegation that Dr. Mutugi had committed a breach of contract in that he had treated a cow belonging to Mr. Wagiciengo of Uplands and had received a fee contrary to his terms of service had not been proved. Threatening Dr. Mutugi by asking him to resign or be sacked was unjustified. This action, in my opinion, proves that the management did not have sound reasons for allegations for the action they took against Dr. Mutugi. The management's unco-operative attitude to the investigator leaves much to be desired.

After careful consideration of the available evidence I conclude that the dismissal of Dr. Mutugi was unjustified. In view of the strained relations between Dr. Mutugi and the management I do not consider that reinstatement will be in the interest of either Dr. Mutugi or the management. I therefore recommend that he be paid:

(a) Three months' salary in lieu of notice in accordance with his terms of service as he had completed his probationary service.

(b) Payment for any leave due.

(c) Three months' salary as compensation for wrongful termination of employment.

(d) Any other claimable expenses he may have incurred in the cause of his duties as per his contract of service."

In accordance with the Ministry's recommendation the claimants asked the respondents to pay a sum of K.Sh. 31,154/20 which included in addition to three months' notice and three months' salary by way of compensation 17 days leave, mileage allowance for June 1977 and subsistence expenses for the same month.

The respondents did not accept the recommendation or the demand and the dispute is now before the court.

During the hearing Dr. Mutugi while giving evidence on oath related a couple of incidents and claimed that he was frustrated in his job by the respondents' top management and that his services were really terminated because he was considered a threat to the post of the then general manager, Mr. Baruch Shugol L.L.B. who Dr. Mutugi claimed knew very little about the veterinary science being a lawyer. The court has full sympathy with Dr. Mutugi on the Mombasa incident when he was treated so shabbily by the respondents' top management at the time. Unfortunately no purpose would be served by going into this incident because the person involved has already left the country.

One other thing that emerged was that while negotiations were going on Dr. Mutugi was offered the post of veterinary coordinator but in the letter of appointment his position was described as Manager, Veterinary Department which Dr. Mutugi claimed was slightly inferior but the fact remains that Dr. Mutugi accepted what was stated in the letter of appointment.

The court is satisfied that on the expiry of six months' probationary period during which time Dr. Mutugi did not receive any adverse reports on his work the respondents did not issue a letter of confirmation to Dr. Mutugi. Instead, on 9th August, 1977 the then general manager, Mr. Baruch Shugol L.L.B. wrote a letter to Dr. Mutugi stating that it had come to their attention that Dr. Mutugi maintained a private practice as a veterinary surgeon and that one Mr. Wagiciengo from Uplands had informed them that Dr. Mutugi had treated his cow and got paid for it and he would hold the respondents responsible for the worsening condition of the cow. The letter referred to paragraph 3 of the letter of appointment and Dr. Mutugi was asked either to resign within three days or expect to be dismissed.

Dr. Mutugi on receiving this letter saw the general manager and asked him to call Mr. Wagiciengo to produce evidence that he had treated his cow. This was refused and as he was convinced that he had no grounds for resigning he decided not to do so. His services were then terminated on 19th August, 1977 as stated hereinabove.

During the evidence Dr. Mutugi stated on oath that he did not know Mr. Wagiciengo and he never treated his cow and went as far as to say that during the week prior to the hearing he did not know Mr. Wagiciengo.

The respondents called Mr. Wagiciengo to give evidence on oath who stated that he knew Dr. Mutugi very well not only as a vet but also through his petrol station at Kariobangi. He went as far as to say that during the week prior to the hearing Dr. Mutugi had burst a tyre and had left Sh. 40 with him to buy a tube and Dr. Mutugi had also told him that he was now practising at Thika. In addition to this Mr. Wagiciengo explained how Dr. Mutugi had treated his cow and he had paid him K.Sh. 200 cash by way of fees. He did not get any receipt. The cow died despite the injection and the tablets that Dr. Mutugi had given. Mr. Wagiciengo explained that he had not in any way threatened to sue the respondents for the loss of his cattle but had asked them to compensate him for the loss. He stated that his intention was not at all that serious in this respect.

This witness was subject to a very vigorous and provocative cross-examination by the Claimants' representative but the court is satisfied from his evidence that he is telling the truth when he says that he knows Dr. Mutugi very well and that the latter treated his cow for which he was paid K.Sh. 200. Mr. Wagiciengo is a former lecturer at the Nairobi University and is now businessman/farmer and is pursuing Ph.D. studies. It is highly unlikely that a man of his standing would come and tell deliberate false stories in a dispute of this nature.

The respondents referred the court to Cause No. 52 of 1974 in which this court had made an award in a dispute involving the question of whether or not there could be an automatic confirmation after the probationary period expired. They argued that confirmation cannot go by default. The facts of that case, however, are different from the present case in that because



the respondents in that case had offered to the person involved an extension of the probationary period by another six months whereas in this case the respondents did no such thing. In the letter of appointment it is clearly stated that after successful completion of probationary period a letter of confirmation will be issued. There is no evidence before the court to suggest that Dr. Mutugi's work during the six months of probation was unsatisfactory in any manner. So he was entitled to be confirmed to that position. The court has come to the conclusion that Dr. Mutugi had qualified to a three months' written notice or salary in lieu thereof for the termination of his service.

After careful consideration of all the submissions the court finds that Dr. Mutugi was in breach of clause 3 of his letter of appointment as he had treated Mr. Wagiciengo's cow for a payment of K.Sh. 200 to him which he had failed to accept on behalf of the respondents or to pay it to them. The court cannot accept the claimants' submission that because this incident is not mentioned in a letter of termination dated 19th August, 1977 therefore the respondents had no reason to terminate his services. On 9th August 1977 the respondents' general manager had referred to this matter when he had asked Dr. Mutugi to tender his resignation. The respondents therefore intended to terminate his services but they should have done so by giving him either three months' notice or pay in lieu thereof along with the other benefits that had accrued to him. The court accordingly awards that the respondents should pay Dr. Mutugi three months' salary in lieu of notice amounting to K.Sh. 13,500, payment for 17 days' accrued leave K.Sh. 2,550, mileage allowance for the month of June, 1977 K.Sh. 1,489 and subsistence expenses for the the same month K.Sh. 115/20.

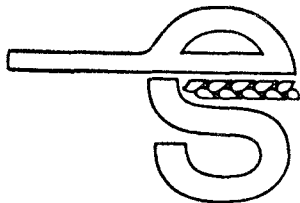

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

### *Kenya Gazette*

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
