1. Collect (by means of questionnaires, international and national publications and other relevant sources), collate and

tabulate statistical data relating to scientific and technical manpower and the funds devoted to scientific and technological activities, and assist in the evaluation, analysis and preparation of this information for publication.

2. Perform technical and administrative work relating to the clearing house activities in science statistics, involving drafting correspondence, abstracting and indexing material for reference use, and the preparation of annotated accessions lists.

3. Act as research assistant in exploiting the data collected, preparing drafts of working documents, reports and papers for use of the division chief and other officials in developing the science statistics programme of Unesco.

4. Assist in studies concerning the promotion of international comparability and the development of a methodology for science statistics with a view to establishing the relevant international standards.

5. Perform other duties related to the statistical programme of Unesco.

## Qualifications and experience required:

- (a) University degree in statistics, mathematics, science, economics or any of the related social sciences, or equivalent competence based upon specialized training and experience.
- (b) Substantial experience in some aspects of applied statistics, preferably in science statistics and in using computerized systems.
- (c) Ability to design statistical tables and arrange data for analysis and publication and ability to carry out statistical searches and organize statistical documentation.
- (d) Fluent knowledge of English or French and working knowledge of the other language; knowledge of other languages of international usage would be an asset.

## Occupational Test No. I

- (i) Should be serving Telephone Operators Grade I (Job Group E) with at least two (2) years service in that grade.

## Occupational Test No. II

- (ii) Should be serving Telephone Operators Grade II (Job Group D), who have been confirmed in their appointment and admitted to the Permanent and Pensionable Establishment; and with at least three years service in that grade.
- (iii) Candidates who attempt and fail Occupational Tests Nos. I and II, will not be allowed to take them until after a period of two (2) years from the date they last attempted the tests.

## CONDITIONS FOR PASSING THE OCCUPATIONAL TESTS

In order to pass any of the occupational tests a candidate is required to pass both the written English (or oral English Test in the case of Blind Telephone Operators) and the practical test at one and the same sitting. No partial passes are allowed.

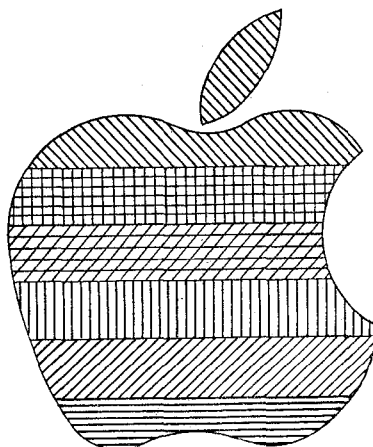

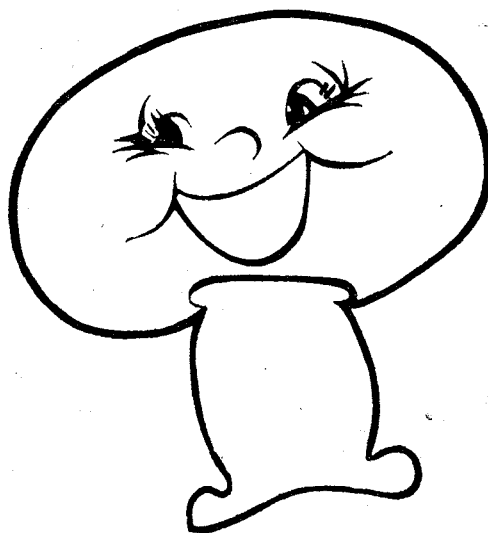
