Refusal by the management to pay Christine Muthone her terminal benefits.

THE Printing and Kindred Trades Workers' Union of Kenya shall hereinafter be referred to as the claimants and Afropress Ltd. shall hereinafter be referred to as the respondents.

2. The painties were heard in Nairobi, on 24th January, and 7th December, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants.—Arther Migoya.

Respondents.—E. N. Wainaina.

AWARD

3. The Notification of Dispute Form "A" dated 18th December, 1979, duly signed by the parties was received by the count on 1st October, 1982, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant started working for the respondents with effect from 7th September, 1967, and was dismissed on 13th June, 1980. He is claiming a sum of KSh. 24,480 which he claims are his salary arrears due from the respondents at the rate of KSh. 1,360 per month from 1st February, 1970, to 31st July, 1971. He further claims from the respondents the difference between his salary and that of Joe De Souza being KSh. 1,540 on the ground that he was underpaid by that figure. He also claims actung allowance. Mr. De Souza's salary at the time was KSh. 3,000 and Mr. Migoya's salary was KSh. 1,460.

The whole dispute revolves around the time when Mr. Migoya was in Germany for advanced training in linotyping and monocasttyping. He went there on a scholarship offered by the German Government to Kenya Government for advanced professional training in Germany. The court is satisfied on the evidence that was produced during the hearing that the respondents' managing director at the time who was a German assisted Mr. Migoya and two of his workmates to get the scholarship through the German Embassy in Nairobi. Mr. Migoya himself made application for this scholarship.

On 16th January, 1970, Mr. Migoya and the respondents signed a document in which it was stated that he would begin "our advanced professional training" in West Germany on 2nd February, 1970, for a period of 1½ years. It was further stated in this document that during this time he would remain a member of the staff of the respondents and on his return he would be obliged to render services to them for a minimum period of two years. It was also stipulated in the same document that the respondents will pay the following contributions to his family for a period of 1½ years commencing on 2nd February, 1970:

"Rent for his house of KSh. 88.50 and any increase that might occur will be paid direct to the Nairobi City Council.

School fees for his three children in Agoro Intermediate School will be paid direct to the school.

The Gadia Mission Hospital will be instructed to render medical care to his three children, invoices for which should be sent to the respondents. Medical treatment was not to include his parents.

An amount of KSh. 170 will be paid to his wife every month which she had to collect from the respondents personally only."

This document in the end stated that if for any reason he failed to come back after his official training this agreement will expire immediately. The same will happen if he failed to complete training in Germay on the foundation sponsorship.

Mr. Migoya has based his claim on this document for claiming salary for eighteen months when he was in Germany. The respondents have strongly resisted this claim saying that although they kept him in their employment they had released him for eighteen months to go for further training on scholarship as stated above and that apart from the benefits stated hereinabove they were not liable to pay him any salary.

The case on the claim for arrears rests on the interpretation of this document. It is obvious that there is no mention of any salary or wage in it whereas the respondents' obligations towards his children, wife and house rent are set out in details. The count cannot believe for a minute that such an important matter as Mr. Migoya's salary during the eighteen months he was to be in Germany was automatically understood and would be paid to him. If the salary was to be paid to him then his would have been the first item to appear in the document. Furthermore the evidence before the court shows that Mr. Migoya on his return from Germany worked for the respondents for about two years without raising any claim for salary for these eighteen months. As a matter of fact he wrote a letter from Germany to the respondents seeking some financial assistance complaining that the allowance paid to him was not enough on which to live. If he had understood that he was to be paid salary for eighteen months he would have asked the respondents to send part of that salary to Germany and not seek some financial assistance.

It is an unfortunate matter that the respondents failed to pay rent to the Nairobi City Council as they had undertaken to do with result that the house was repossessed by the City

Council but when Mr. Migoya came back he was given KSh. 1,440 to look for accommodation. The respondents, however, paid the amount as agreed to Mrs. Migoya at the rate of KSh. 170 per month and complied with the other conditions also. In these circumstances the court cannot accept the claimants' submission that the afforesaid agreement places an obligation on the respondent to pay Mr. Migora salary for eighteen months he was in Germany. It should be noted that the allowance that he was receiving in Germany was more than his monthly salary. Mr. Migoya admitted in cross-examination that his other colleague who was in Germany with him did not complain about any salary although he did say that perhaps he was paid. The respondents, however, denied that the colleague was paid any salary. The count is quite satisfied that Mr. Migoya knew that for the eighteen months he was to pursue advanced professional training in Germany he was not to be paid any salary as the respondents would not be benefitting from any service from him during that period. The fact that the respondents agreed to keep him in employment does not in the absence of a clear undertaking to that effect make them responsible to pay him salary for that period, Indeed Mr. Migoya is lucky that the respondents looked after his children Migoya is licky that the respondents looked after his children and wife although they overlooked to pay rent to the Nairobi City Council. The court cannot accept Mr. Migoya's claim for payment of arrears of salary for this period amounting to KSh. 24,480 but the court feels that the respondents should pay him the house allowance they failed to remit to the Natirobi City Council. The court awards that they should pay him KSh. 2,700 only.

The court would now like to deal with his other claims of acting allowance and promotion. On the question of promotion the court would immediately dispose of this point because it would indeed be riidiculous for any employee to assume and take for granted that he is promoted after training in the absence of any clear letter to that effect. The court does not believe that Mr. Migoya had been promoted to Mr. De Souza's place when the latter left. In fact the evidence suggests that Mr. De Souza's responsibilities were taken over by the manager. The court would like to emphasize that promotion is a management prerogative and the court cannot accept a claim by an employee that he should have been promoted.

Regarding the other claim of acting allowance apart from the fact that the court was given the salaries of Mr. De Souza and Mr. Migoya, there is absolutely no other evidence to suggest that Mr. Migoya was asked to act in Mr. De Souza's place for any period of time. The claimants failed to give any details to the court. The court was not even given the dates when it is alleged Mr. Migoya acted in place of Mr. De Souza and it is indeed a very vague claim.

In the end the court would like to add that it is not a genuine claim and Mr. Migoya is only giving vent to his frustrations for not having been promoted as he thought he would be on his return from Gremany. This is a mere speculative claim and the court must reject it. Mr. Migoya is entitled to only KSh. 2,700 which the court has awarded above and which the court directs the respondents to pay him.



All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
