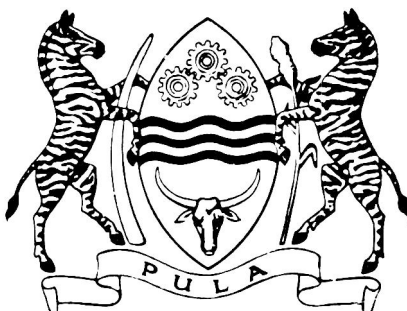

ELECTORAL ACT

(Cap. 02:07)

Notice of Publication of Supplementary Voters Rolls

IN ACCORDANCE with the provisions of section 13 of the Electoral Act, notice is hereby given that the Supplementary voters rolls of the voters registered during the period 1st July, 1974, to 31st December, 1976, both dates inclusive, in the constituencies specified in the first column of the Schedule have been completed and copies are available for inspection at the office of the Supervisor of Elections and at the office of the Principal Registration Officer for the said constituencies and at the places set forth in the second column of the said Schedule in respect of each of the said constituencies.

Any person who is registered as a voter in one of the said constituencies who wishes to object to the inclusion in the roll for that constituency of any person's name should send or deliver his objection to the Principal Registration Officer of the constituency at the address specified in the third column of the said Schedule so as to reach him not later than 17th January, 1977. Objections must be made on the prescribed form and must be accompanied by a deposit of P1.
