MEMORANDUM

A draft of the above Bill, which it is which it is proposed to present to the National Assembly, is set out below.

- 2. Since Independence there have been two general elections in Botswana and following each election the Supervisor of Elections has, in his report, suggested certain amendments to the Electoral Act (Cap. 02:07). This Bill proposes that such amendments be effected.
- 3. The Electoral Act at present provides that there shall be one general registration period for all constituencies throughout Botswana. This means that registration must take place simultaneously at all 345 polling stations. This necessitates the use of inexperienced registration officers which gives rise to inaccuracies in the voters' rolls. It is proposed that the Electoral Act be amended to permit the appointment of a general registration period in respect of all or any constituencies. The proposed amendment, contained in clause 2, will permit the use of trained teams of registration officers travelling the country and will minimize the risk of inaccuracies. A consequential amendment is proposed by clause 3.
- **4.** Clause 4 proposes an amendment to section 12 to require that a person's full names, not merely initials, appear on an election roll, thus minimizing the chances of confusion over people with identical initials.
- **5.** Clause 5 proposes an amendment to section 32 to require that where a proposer, seconder or supporter is unable to sign his name, he may affix his mark and that such mark shall be witnessed by a person who can sign his name.
- **6.** Clause 8 proposes the revocation of section 35, which requires each candidate to apply for a certificate of proficiency in English. Proficiency in English will remain a qualification for membership of the National Assembly, but it is considered unnecessary to require the production of such a certificate when a candidate is not required to produce a certificate that he is not otherwise disqualified. Consequential amendments are proposed by clauses 5, 6 and 13.
- 7. Clause 9 proposes an amendment to section 46 to remove the requirement that every ballot envelope be stamped prior to its issue to a voter. A strict check is kept on the number of envelopes issued to polling officers and this requirement is considered unnecessary.
- **8.** Clause 10 proposes an amendment to section 52 to provide that a polling officer shall, instead of putting the number of the ballot envelope issued to a voter against his name on the election roll, merely make a mark on the roll to show that a ballot envelope was issued. This will ensure a truly secret ballot.
- **9.** Clause 11 proposes an amendment to section 56 to enable a presiding officer to issue another ballot envelope to a voter who has accidentally placed his first envelope in the discard box. Clause 12 proposes a consequential amendment to section 66.
