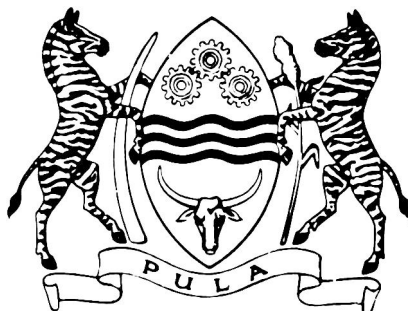

Assizing - Kanye

NOTICE IS HEREBY GIVEN under the provisions of section 17 (1) of the Weights and Measures Act that all persons having weighing and measuring instruments, weights or measures in use in trade or in their possession or charge for use in trade, within the area specified in the Schedule, are required to produce the same to an assizer for the purpose of their being assized or re-assized at the place specified and at the appropriate time specified in the said Schedule.
