AFFILIATION PROCEEDINGS (AMENDMENT) BILL, 1977

(Published on 25th March, 1977)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

- 2. The object of the Bill is to amend the Affiliation Proceedings Act, 1970, so as to provide
 - (a) that the mother of an illegitimate child may lay a complaint under the Act at any time after the expiry of the usual period of twelve months after the birth of the child, where her failure to do so during that period was influenced by conduct on the part of the alleged father which there are reasonable grounds to believe was dishonest;
 - (b) that where the alleged father ceased to reside in Botswana within a year after the illegitimate child's birth, the mother may lay a complaint under the Act at any time after his return to Botswana (at present she may only do so during the year immediately after his return);
 - (c) that a complaint may no longer be laid solely on proof that the alleged father, within a year of the child's birth, helped to maintain the child;
 - (d) for the payment under an affiliation order of a specified lump sum by the putative father in place of weekly or monthly payments;
 - (e) to empower the court, in certain circumstances, to order the payment by the putative father of a sum equal to the total amount that would have been due under the affiliation order if it had been made at birth;
 - (f) to reduce the age level, at which payments under an affiliation order normally cease, from sixteen to thirteen years; and to reduce the age level, at which further such payments, made because the child is undergoing education or training, shall cease, from twenty-one to sixteen years;
 - (g) that no magistrate's court shall have jurisdiction to entertain a complaint under the Act where affiliation proceedings in respect of the same child are pending, or have been decided upon the merits, in a customary court.

- (4) Where a complaint under section 3 is made before or within two months after the birth of the child, the order, if made after the birth, may require, in addition to the payment of a sum of money weekly or monthly, the payment of a specified lump sum of money equal to the aggregate amount that would, at the time the order is made, have been otherwise due under the order if it had been made on the date of birth; and such sum shall be paid forthwith or within such reasonable period as the order may specify.
- (5) An order may require the payment of the child's funeral expenses if the child has died before the order is made.
- (6) An order may require that on the child reaching the age of seven years a specified amount from every sum thereafter payable weekly or monthly under the order shall be expended on the education of the child.".

 - "(9) Subject to the provisions of this Act, an order shall not, except for the purpose of recovering money previously due under the order, be of any force or validity after the child has attained the age of thirteen years or has died.".
