AND WHEREAS I will be absent from Botswana from 5.30 p.m. on 12th July, 1977, and consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid, I authorize you, the said Quett Ketumile Jonny Masire, in your capacity as Vice-President, to discharge, with effect from 5.30 p.m. on the said 12th July, 1977, all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;

 - provisions of section 42 of the Constitution; Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;
- (c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution.
