NOTICE IS HEREBY GIVEN under the provisions of section 17 (1) of the Weights and Measures Act that all persons having weighing and measuring instruments, weights or measures in use in trade or in their possession or charge for use in trade, within the area specified in the Schedule, are required to produce the same to an assizer for the purpose of their being assized or re-assized at the place and at the appropriate time specified in the Schedule.

GS 10 DRILLING CONTRACT

BRANDING OF CATTLE (AMENDMENT) BILL, 1977

(Published on 22nd July, 1977)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The Bill proposes amendments to the Branding of Cattle Act (Cap. 36:02) ("the Act") which are considered necessary and desirable to protect the interests

of authorized creditors under the Hypothecation Bill, 1977.

- 3. Clause 2 proposes amendments to section 2 of the Act to insert definitions of "AC brand" and "authorized creditor". Clause 3 proposes amendments to section 13 of the Act to provide for the form of an AC brand, and clause 4 seeks to amend section 14 so that only an authorized creditor may apply for the registration of an AC brand.
- **4.** Clause 6 proposes amendments to section 18 of the Act to provide for a directory of AC brands and for the publication of that directory twice a year in the Gazette. Clause 10 seeks to amend section 22 of the Act to require that AC brands be imprinted on the right forearm of an animal and that cancellation of such a brand be by way of a reverse imprint thereof below that last AC brand. MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

- 2. This Bill proposes the amendment of the Control of Livestock Industry Act (Cap. 36:01) in a manner considered necessary and desirable for the protection of the rights of an authorized creditor under the Hypothecation Bill, 1977, and the National Development Bank under the Agricultural Charges Act (Cap. 35:01). It is proposed that this be achieved by placing restrictions on the sale of hypothecated or charged cattle and requiring the issue of a certificate on the sale of cattle not so hypothecated or charged.
- 3. Clause 3 proposes a consequential amendment to section 33, which relates to penalties.

- 2. The Bill proposes amendments to the Pounds Act (Cap. 36:05) which are considered necessary and desirable to safeguard the interests of authorized creditors under the Hypothecation Bill, 1977.
- 3. Broadly speaking, the amendments forbid the sale or destruction of any impounded animal which is subject to a hypothecation or charged to the National Development Bank without the consent of the authorized creditor concerned. Notice of such impounding is required to be given to the authorized creditor concerned, and no sale of any such animal can take place without the consent of such authorized creditor.

The Minister is hereby empowered to sign on behalf of the Government of Botswana any agreements embodying the terms and conditions of the loan as agreed in accordance with section 2, and to authorize any public officer to sign such agreements, and to do all such things as may be necessary to effect or facilitate such loan or such agreements.
