Declaration of Infected Area - Mahalapye

IN EXERCISE of the powers conferred by section 4 of the Diseases of Animals Act, 1977, the Director of Veterinary Services hereby declares all the area within 10 km of the police station at Mahalapye to be an infected area as regards rabies.
