#### COMPANIES ACT (Cap. 42:01)

## **Overpayment of Penalties**

DUE to inadvertence a number of companies were, during the period 1st April, 1974, to 1st August, 1977, charged excess fees or penalties in respect of the submission of various forms and returns made to the Registrar of Companies. This arose as it was mistakenly believed that the revised Seventh Schedule substituted by Statutory Instrument No. 13 of 1974 and amended by Statutory No. 19 of 1975 had retrospective effect. This was not so. Furthermore, penalties were also inadvertently charged for the non- or late submission of the certificate under section 96 (4) of the Act in the mistaken belief that such certificate formed part of the annual return required of each company.
