DIPLOMATIC IMMUNITIES AND PRIVILEGES (AMENDMENT) BILL, 1977

(Published on 11th November, 1977)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

- 2. Under the Diplomatic Immunities and Privileges Act (Cap. 39:01) the President may confer diplomatic immunities and privileges only on a restricted class of international organizations and on the representatives, committee members, officers and envoys, and the like, of such organizations. These organizations must, as the law stands, be international organizations of which Botswana or its Government is a member.
- 3. Examples of such organizations, on which the President has conferred diplomatic immunities and privileges, are the United Nations Organization and the Organization of African Unity.
- 4. The object of the Bill is to amend the Diplomatic Immunities and Privileges Act in order to remove the requirement that Botswana or its Government must be a member of an international organization before the President may confer diplomatic immunities and privileges on it and its representatives and officers, and the like.
- 5. If enacted the Bill will enable the President to confer such immunities and privileges, for example, on the European Economic Community of which Botswana is not a member, although it has a close treaty relationship with the Community.
