

**Applications for Government of Botswana Treasury Bills**

The Minister of Finance and Development Planning hereby gives notice that applications will be received at the Bank of Botswana, Khama Crescent, Gaborone, on Thursday, 5th January, 1978, at 12 noon, for Treasury Bills to be issued under the Stock, Bonds and Treasury Bills Act, 1976, and in accordance with the Treasury Bills Regulations, 1976, to the amount of P500 000.

2. The price at which the Bills will be offered will be published by the Bank of Botswana not later than 9 a.m. on Friday, 5th January, 1978.
3. The Bills will be in amount of P1 000 or a multiple of P1 000. They will be dated 16th January, 1978 and will be due 180 days after date.
4. The Bills will be issued and paid at the Bank of Botswana.
5. Each application must be for a minimum of P1 000.
6. Applications must be made through a commercial bank in Botswana.
7. Notification will be sent, on the same day as applications are received, to the persons whose applications are accepted in whole or in part.
8. Payment in full of the amount due in respect of such accepted applications must be made to the Bank of Botswana by means of cash or by draft or cheque drawn on the Bank of Botswana not later than noon on the day on which the relative Bills are to be dated.

1. 162 rolls  $\times 12 \times 2\frac{1}{2}$ " diamond mesh galvanized wire — 4' high
2. 1620 mild steel droppers — 4' high "T" section
3. 18 tubular gates steel, farm type —  $10' \times 4'$  high constructed 1" tube and covered with woven mesh.
4. 18 tubular gates steel, pedestrian type —  $4' \times 4'$  high constructed of 1" tube and covered with woven mesh.
