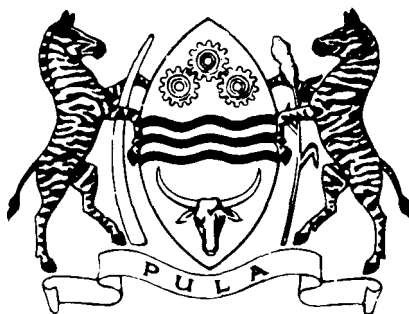

**Applications for Government of Botswana Treasury Bills**
