DISEASES OF ANIMALS (AMENDMENT) BILL, 1978 (Published on 17th February, 1978)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. By virtue of section 20 of the Diseases of Animals Act, 1977, (9 of 1977), any person guilty of an offence under the Act itself or under any subsidiary legislation made thereunder is liable to a maximum punishment of a fine of P1 000 and imprisonment for one year.

3. To ensure the future of Botswana's meat export industry it is important that the Act and subsidiary legislation made under it are strictly obeyed.

4. To encourage such obedience, and to impress on everyone the great importance of the Act and the subsidiary legislation made under it, it is considered desirable to amend section 20 of the Act in order to increase the penalties and, in addition, to empower the courts to award corporal punishment.

5. The object of the Bill, therefore, is to amend the Diseases of Animals Act, 1977, in order to increase the penalties and to include corporal punishment among the punishments that may be awarded for a breach of the Act itself or of subsidiary legislation made thereunder.
