# SELEBI-PHIKWE TAX AGREEMENT (AMENDMENT) RATIFICATION BILL, 1978

(Published on 24th February, 1978) MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

The object of the Bill is to give legal effect, for the purposes of paragraph (xxiv) of Part II of the Second Schedule to the Income Tax Act (Cap. 52:01), to the amendment to the tax agreement set out in the Schedule to the Selebi-Phikwe Tax Agreement Ratification Act, 1970, (No. 6 of 1970), (which, in this Memorandum, is referred to as "the principal agreement"), effected by the agreement set out in the Schedule to the Bill.

In accordance with the principal agreement, the above mentioned provision of the Income Tax Act exempts from income tax any amount payable by BCL Limited by way of interest to any non-resident who does not carry on business in Botswana through a permanent establishment situated in this country.

The relevant mining lease provides that in certain circumstances the royalty payable to the Government thereunder may be paid in promissory notes of BCL Limited.

The amendment to the principal agreement effected by the agreement set out in the Schedule to the Bill makes it clear that "interest", for the purposes of the above mentioned provision of the Income Tax Act, includes interest payable on promissory notes issued by BCL Limited, under the note agreement referred to in the agreement set out in the Schedule to the Bill, to the Government in payment of the royalty, provided that the notes are in respect of monies applied for the purposes of the mining operations carried on by BCL Limited in terms of the principal agreement.

It should be noted that neither the agreement set out in the Schedule to the Bill, nor the note agreement therein referred to, has yet been executed. The relevant dates and the names of the persons executing and witnessing the agreement will be inserted in the Bill at the committee stage.

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Employees of land boards are all officers in the unified local government service and have always been treated as employees of local councils for the purposes of the Local Councils' Employees Provident Fund Act (Cap. 40:05) and thus as participants in the Fund.

3. It has recently been noted, however, that the definition of "local council" in that Act does not include a land board.

4. The principle object of the Bill, therefore, is to amend the definition of "local council" in section 2 of the Local Councils' Employees Provident Fund Act so that it includes a land board. The amendment would have effect from 30th January, 1970, the date on which the Tribal Land Act (Cap. 32:02) came into operation. It is by or under this Act that land boards are established. Thus past participation of employees of land boards in the Local Councils' Employees Provident Fund would be validated.

5. A secondary object of the Bill is to bring the definitions of "township authority" and "town council" into line with the definitions thereof found in section 2 of the Unified Local Government Service Act (Cap. 40:07).
