# STOCK, BONDS AND TREASURY BILLS ACT, 1976 (6 of 1976)

## TREASURY BILLS REGULATIONS, 1976 (S.I. 143 of 1976)

#### Applications for Government of Botswana Treasury Bills

The Minister of Finance and Development Planning hereby gives notice that applications will be received at the Bank of Botswana, Khama Crescent, Gaborone on Thursday, 18th May, 1978, at 12 noon, for Treasury Bills to be issued under the Stock, Bonds and Treasury Bills Act, 1976, and in accordance with the Treasury Bills Regulations, 1976, to the amount of P1 000 000.

2. The price per cent at which the Bills will be offered will be published by the Bank of Botswana not later than 9 a.m. on Thursday, 18th May, 1978.

# **COMMONWEALTH COUNTRIES BILL, 1978**

(Published on 19th May, 1978)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The Bill proposes to repeal and replace the Commonwealth Countries Act (Cap. 25:02) which extends the application of section 27 of the Constitution to certain countries.

3. By virtue of section 27 of the Constitution, every person who is a citizen of a country to which that section applies shall also have the status of a Commonwealth citizen.

4. Section 27 should apply to all independent member countries of the Commonwealth. The section has not, however, over the years been extended to all those countries which have become members of the Commonwealth in their own right since the Constitution was originally drafted.

5. The principal object of the Bill, therefore, is to extend section 27 of the Constitution to all those countries which have become members of the Commonwealth in their own right since 1966. This is effected by clause 2 of the Bill read with the Schedule to the Bill.

6. Clause 3 of the Bill provides that section 27 of the Constitution shall be deemed to have ceased to apply to Pakistan on 1st February, 1972. Pakistan left the Commonwealth on that date.

7. Finally, clause 4 of the Bill removes any doubts that may arise in construing section 27 of the Constitution because of Ceylon's change of name to Sri Lanka on 22nd May, 1972.
