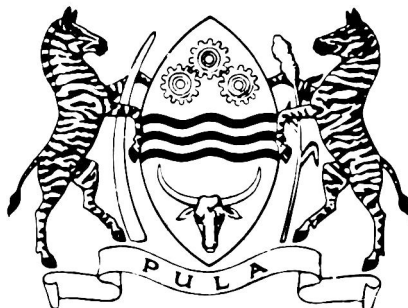

MEMORANDUM OF AGREEMENT made and entered into by and between the GOVERNMENT OF THE REPUBLIC OF BOTSWANA (hereinafter referred to as

"the Government"), and DE BEERS BOTSWANA MINING COMPANY (PROPRIETARY) LIMITED (hereinafter referred to as "the Mining Company"), and THE DIAMOND CORPORATION BOTSWANA (PROPRIETARY) LIMITED (hereinafter referred to as "Dicorbot"); the Mining Company and Dicorbot being companies incorporated under the laws of Botswana having their respective registered offices at Botsalano House, The Mall, Gaborone.

WITNESSETH:

THAT WHEREAS on the 2nd March 1970 an agreement was entered into between the Government and the Mining Company providing for the payment of tax and royalty, such agreement being amended by further agreements entered into between the same parties dated the 10th August, 1972 and between Government, the Mining Company and Dicorbot dated 22nd July, 1975 (such agreement as so amended being hereinafter referred to as "the Agreement").

AND WHEREAS the Agreement was ratified by Acts of Parliament, namely the De Beers Botswana Mining Company (Proprietary) Limited Agreement Act, 1970, the De Beers Botswana Mining Company (Proprietary) Limited Agreement (Amendment) Act, 1972 and the De Beers Botswana Mining Company (Proprietary) Limited Agreement (Amendment) (Ratification) Act, 1975.

AND WHEREAS it has been agreed to amend the Agreement further to make provision for the Jwaneng Mine.

NOW THEREFORE the parties hereto agree as follows:—

1. Clause 2 of the Agreement is hereby deleted.
2. The new clause inserted by Clause 3 of the agreement of 22nd July, 1975 is deleted and replaced by the following:
