



Before the Honourable Mr Justice J.B. Edwards at Lobatse on Friday the 28th April, 1978.

UPON HEARING Mr Ackerman, Attorney for Applicant; and after reading documents filed of record:
IT IS ORDERED

1. That the applicant be, and is hereby, cautioned to institute by edictal citation an action in which the Applicant claims against the Respondent presently residing in the Federal Republic of Germany at the care of Armin Kroll, Mieder-Mörler Strasse 65A, 6350 Bad Nauheim — NM P4 795,75, as moneys lent and advanced.
2. That the citation, interdict and any other necessary process such action shall be secured presumably until Respondent through the competent authorities of the Federal Republic of Germany.
3. That if the Respondent wishes to defend to the said action she shall give notice of intention to defend by letter posted by registered airmail so as to reach the Registrar and the Applicant's attorneys within 4 weeks of the date of service of the citation on the Respondent, and shall thereafter comply with the requirements of the Rules of Court in respect of filing of pleadings.
4. That the Rule Nisi do hereby issue calling upon the Respondent and any other interested person to appear by attorney or in person before this Honourable Court on the 29th September 1978 to show cause (a) why the following property of the Respondent shall not be attached by the Deputy Sheriff of this Honourable Court, namely —
 - (i) one safe-deposit box left at the Lobatse branch of the Applicant bank;
 - (ii) one house and rondavel at Oodi together with the contents thereof.
- (b) Why the costs of this application shall not be costs in the said action.
5. That the said Rule operate as an interim attachment of the said property.

2. The object of the Bill is to prescribe a rate of interest on judgement debts. At common law the rate of interest is 6 per centum which does not reflect the present economic realities of the 20th century. The rate of interest at common law is now considered out-dated.

3. Section 3 provides that if the rate of interest has not been fixed by any Act or agreement or trade custom then the prescribed rate of interest shall apply to such judgement debt, unless the Court orders otherwise.

4. The Minister is under section 3 (2) empowered to prescribe the rate of interest.

5. Section 4 provides that every judgement debt which would not be subjected to interest were it not for that provision shall bear interest at the prescribed rate from the date determined by the Court.

Interest on a debt to be calculated at a prescribed rate

3. (1) If a debt bears interest and the rate at which the interest is to be calculated is not governed by any other written law or by an agreement for a trade custom or in any other manner, such interest shall be calculated at the rate prescribed under subsection (2) as at the time when such interest begins to run, unless a court, on the ground of special circumstances relating to that debt, orders otherwise.

(2) The Minister by notice published in the gazette may prescribe a rate of interest for the purposes of subsection (1).

Interest on a judgement debt

4. (1) Every judgement debt which but for the provisions of this subsection would not bear interest after the date of the judgement or order by virtue of which it is due shall bear interest at the rate prescribed under section 3 from the day on which such judgement debt is payable, unless that judgement or order provides otherwise.

(2) Interest payable in terms of subsection (1) may be recovered as if it formed part of the judgement debt on which it is due.
