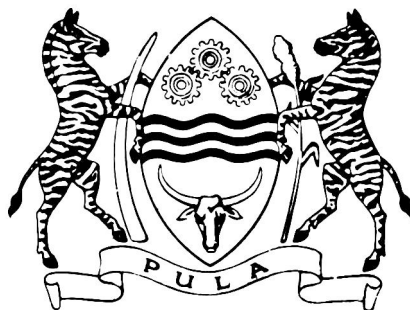

**Applications for Government of Botswana Treasury Bills**

The Minister of Finance and Development Planning hereby gives notice that applications will be received at the Bank of Botswana, Khama Crescent, Gaborone, on Thursday, 31st August, 1978, at 12 noon, for Treasury Bills to be issued under the Stock, Bonds and Treasury Bills Act, 1976, and in accordance with the Treasury Bills Regulations, 1976, to the amount of P1 000 000.

2. The price per cent at which the Bills will be offered will be published by the Bank of Botswana not later than 9 a.m. on Thursday, 31st August, 1978.

3. The Bills will be in amount of P1 000 or a multiple of P1 000. They will be dated 1st September, 1978, and will be due 91 days after date.

4. The Bills will be issued and paid at the Bank of Botswana.
