

# BRITISH SOUTH AFRICA COMPANY LAND (AMENDMENT) BILL, 1979

(Published on 10th August, 1979)

# MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Under the existing provisions of section 5 of the British South Africa Company Land Act (Cap. 32:06) all roads and thoroughfares existing at 7th February, 1905, over Gaborone Block, Lobatse Block and the Tuli Block are to remain free and uninterrupted. Some of these roads or thoroughfares are unauthorized entry points into or out of Botswana. In other words, aliens can use some of these entry points to enter the country without complying with our immigration laws. The main object of the Bill, therefore, is to amend section 5 of the British South Africa Company Land Act by bringing it in line with the Immigration Act (Cap. 25:04) so far as it relates to aliens entering or leaving the country.
