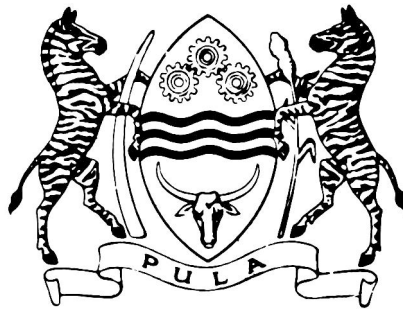

**IMMIGRATION (AMENDMENT) BILL, 1980**

*(Published on 11th January, 1980)*

**MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The effect of the Immigration (Amendment) Act, 1979, (19 of 1979), was to remove from the Minister all his powers to issue residence permits in the first instance and to transfer those powers to the Immigrants Selection Board.

3. However, it has become apparent in practice that it is necessary from time to time for the Minister to be able to short circuit the procedure of application to and consideration and determination by the Immigrants Selection Board.

4. The object of the Bill, therefore, is to amend the Immigration Act (Cap. 25:04) in order to give the Minister the power, in special circumstances which apply in the case of an individual person, to issue a residence permit, whether or not an application for such a permit has been made to the Immigrants Selection Board.

(1) Notwithstanding the provisions of section 19, where the Minister is satisfied that by reason of any special circumstances which apply in the case of any person who has entered Botswana and is not a prohibited immigrant it is desirable for a residence permit to be issued to that person without an application therefor being considered and determined by the Board, he may, whether that person has or has not applied for a residence permit, issue a residence permit to that person.

(2) A residence permit issued under this section shall be issued in the prescribed form for such period, not exceeding 3 years, as the Minister shall determine and may be issued subject to such conditions as the Minister may determine, which conditions shall be specified in the permit.

(3) The Minister may, at any time, —

- (a) by notice in writing given to a particular holder of a residence permit issued under this section; or
  - (b) by notice published in the Gazette applying to all such holders of any specified class,
- vary the conditions for the time being attached to such a residence permit.

(4) The particular holder of a residence permit to whom notice in writing has been given under subsection (3) (a) shall forthwith transmit his permit to the Minister and the conditions therein specified shall be varied in accordance with the notice and the permit returned to the holder.

(5) The holder of a residence permit issued under this section who contravenes subsection (4) or who fails to comply with any condition for the time being attached to his permit shall be guilty of an offence and liable to the penalties prescribed by section 29 (2).

(6) The Minister may from time to time renew a residence permit issued under this section if the holder thereof has not become a citizen of Botswana.”.

**PRISONS (AMENDMENT) BILL, 1980**  
*(Published on 11th January, 1980)*

**MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Section 13 (*d*) of the Prisons Act, 1979, (28 of 1979), substantially reproduces section 10 (*d*) of the Prisons Act (Cap. 21:03) and provides for the summary dismissal of any prison officer on his conviction of an offence other than an offence under the Act itself.

3. The provision, it is now appreciated, is defective. The power of summary dismissal is also needed where a prison officer is convicted of an offence under the Act itself and, in addition, where a prison officer is convicted outside Botswana of an offence which is a criminal offence under the law of Botswana.

4. Offences under the Act itself which might be committed by a prison officer are mutiny and related offences (section 29); desertion (section 30); inciting prison officers to desert (section 31); resignation from the Prison Service without permission (section 32); taking part in certain prohibited activities (section 33); assault on an officer senior in the Service (section 34) and, where the offender is a male prison officer, entering or remaining in a cell in which a female prisoner is confined without being accompanied by a female prison officer (section 35).

5. The object of the Bill is to amend section 13 of the Prisons Act, 1979, by substituting a new paragraph (*d*) to cure the present defective provision.
