MINES AND MINERALS (AMENDMENT) BILL, 1980

(Published on 25th April, 1980)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Section 13 (2) of the Mines and Minerals Act (Cap. 66:01) provides that no reconnaissance permit shall be issued in respect of any area over which a prospecting licence or a mining lease is in existence.

3. The first object of the Bill is to remove this provision from the Act so that a reconnaissance permit may be issued in respect of an area over which a prospecting licence or mining lease is already in existence.

4. By virtue of section 71 of the Act every holder of a prospecting licence or restricted prospecting licence must pay an annual charge to the Government.

5. The same section provides that, where such a licence is in respect of land in a tribal territory, one-half of the annual charge shall in due course go, as a grant-in-aid, to the district council within which area the land is situated.

6. For the purposes of the Act "tribal territory" means —

(a) tribal territory as defined in the Tribal Territories Act (Cap. 32:03);
and

(b) the area of the Barolong Farms.

7. Tribal territories, as defined in the Tribal Territories Act, comprise the Bamangwato, Batawana, Bakgatla, Bakwena, Bangwaketse, Bamalete and Batlokwa Tribal Territories.

8. The second object of the Bill is to amend the Act so that section 71 shall apply, so far as grants-in-aid to district councils of one-half of prospecting licence and restricted prospecting licence charges are concerned, in every case where such a licence is in respect of land in a tribal area as defined in the Tribal Land Act (Cap. 32:02).

9. Tribal areas, as so defined, include not only tribal territories, as defined in the Tribal Territories Act, and the Barolong Farms but also the area defined in the Second Schedule to the Tribal Land Act.

10. The practical effect of the Bill will be that a district council the area of which is within the area defined in the Second Schedule to the Tribal Land Act will also be entitled to receive, as a grant-in-aid, one-half of the annual charge for any prospecting licence or restricted prospecting licence granted over land within the council's area.
