 - (c) in any case where the Commissioners are satisfied that a recipient was not vested with the required proprietary rights in the prescribed number of livestock units to qualify as aforesaid or was not otherwise qualified as aforesaid, the nature of the arrangements or representations made to enable the recipient so to qualify or to appear so to qualify;
 - (d) in the case of each recipient, whether he has or does not have the sole beneficial enjoyment of the ranch allocated to him and, where the Commissioners are satisfied that he does not have such sole beneficial enjoyment, the identity of the person for whose benefit or partly for whose benefit the ranch is managed and the nature of the relation and arrangements, social, economic, familial or otherwise, between the recipient and that other person;
 - (e) in the case of each such ranch, whether there is or is not any person other than the recipient who has charge or control, either wholly or in part, of the development or management thereof and, where the Commissioners are satisfied that there is such a person, the nature of the arrangements between the recipient and that other person, including the manner in which that other person is rewarded:
 - (f) in the case of each such ranch, whether any loan or other cash resource has or has not been raised for the development of the ranch and, where a loan or other cash resource has been so raised, the identity of the source thereof, of the person by whom or to whose order the proceeds thereof are held and of the person (if any) who provided security therefor, the terms governing the loan or the raising of the other cash resource and the terms under which such security was provided;
 - (g) where in the case of a loan or other cash resource such as is referred to in subparagraph (f) the Commissioners are satisfied that the same was procured by an agent, the identity of the agent and the terms of the agency;
 - (h) the nature of the relations between all the recipients, including -
 - (i) familial relations;
 - (ii) relations of master and servant, principal and agent or beneficiary and trustee; and
 - (iii) economic or business relations (such as, for example, relations arising out of the provision of development assistance or of access to land for the purpose of watering or grazing cattle or fencing arrangements).
