

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Local Government Tax Short title (Amendment) Act, 1980, and shall come into operation on 1st and commencement January, 1981.

2. The First Schedule to the Local Government Tax Act Amendment (hereinafter referred to as "the principal Act") is amended by substituting for the General Scale therein set out the following to Cap. 40:04 new General Scale –

EUROPEAN INVESTMENT BANK LOAN (AUTHORIZATION) BILL 1980

(Published on 17th November, 1980)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to authorize the raising by the Government of a loan from the European Investment Bank of an amount of European Units of Account 1.5 million (equivalent, at the time of writing, to approximately P1.4 million).

3. The purpose of the loan is to develop the second phase of the Vaccine Plant.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the European Investment Bank Short title Loan (Authorization) Act, 1980.

2. The Minister may raise by loan from the European Authorization Investment Bank, subject to such terms and conditions as may be to raise a loan agreed between the Minister and the European Investment Bank, sums not exceeding in the aggregate the equivalent of European Units of Account 1.5 million (one million five hundred thousand European Units of Account) for the purpose of developing the second phase of the Vaccine Plant.

Loan charged upon Consolidated Fund Powers of the Minister in connexion

3. The proceeds of the loan authorized to be raised by this Act (hereinafter referred to as "the loan") shall be paid into the ^{1t} Development Fund.

4. All sums required to repay the loan and to pay the interest and other charges thereon shall be charged upon and paid out of the Consolidated Fund.

5. The Minister is hereby empowered to sign on behalf of the Government and to authorize any public officer so to sign any agreements embodying the terms and conditions of the loan and to do all such things as may be necessary or expedient to effect or facilitate the loan or such agreements.

As soon as practicable after the raising of the loan the Minister shall lay before the National Assembly a paper containing a report on the loan which shall include the terms and conditions of the loan and any other information relating thereto which the Minister considers appropriate to include.
