WEIGHTS AND MEASURES ACT (Cap. 43:06)

Assizing - Selebi-Phikwe and Francistown

IT IS HEREBY NOTIFIED, under the provisions of section 17 (1) of the Weights and Measures Act, that all persons having weighing or measuring instruments, weights or measures in use in trade or in their possession or charge for use in trade, within the areas specified in the Schedule, are required to produce the same to an assizer for the purpose of their being assized or re-assized at the place specified and at the appropriate time specified in the Schedule.
