

## SMALL LOTTERIES (AMENDMENT) BILL, 1981

(Published on 13th March, 1981)

## **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Under section 3 of the Small Lotteries Act (Cap. 19:02) as amended by section 3 of the Small Lotteries (Amendment) Act, 1980, the only organizations which can conduct lotteries under the Act are societies registered under the Societies Act (Cap. 18:01). The main intention for the enactment of the Small Lotteries Act, however, is to enable charitable organizations, whether registered under the Societies Act or not, to conduct lotteries.

3. The main object of the Bill is therefore to amend section 3 of the Act to enable charitable institutions to conduct lotteries under the Act. Consequently the Minister is empowered to prescribe such institutions as he considers as charitable institutions for the purposes of the Act.

Amendment of section 3 of Cap. 19:02 2. The Small Lotteries Act is herey amended by substituting for section 3 thereof the following new section —

"Small Lotteries deemed lawful

- 3. (1) A lottery shall be deemed to be lawful if it is promoted on behalf of
  - (a) a society registered or exempted under the Societies Act; or
  - (b) an institution or organization prescribed as a charitable institution,

and is promoted and conducted in accordance with the provisions of section 6.

(2) The Minister may, by statutory instrument, make an order prescribing such institutions or organizations which he deems fit to be charitable institutions or organizations for the purposes of this Act.".
