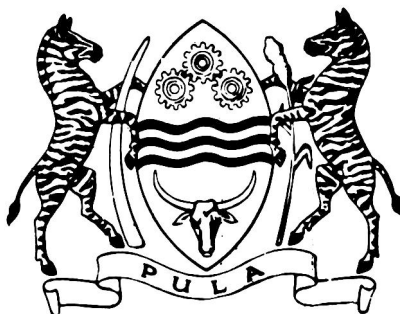

# **CONTROL OF DEALINGS IN LIVESTOCK BILL, 1981**

*(Published on 8th May, 1981)*

## **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to enable the Minister for the time being responsible for agriculture, by means of regulations, to take such steps as he considers necessary or expedient in the interests of Botswana to control dealings in livestock.

3. The form of the Bill closely follows that of the Control of Goods, prices and Other Charges Act (Cap. 43:07), which empowers the Minister for the time being responsible for commerce, by means of regulations, to control the marketing of goods.

**ENACTED** by the Parliament of Botswana

1. This Act may be cited as the Control of Dealings in Livestock Act, 1981, and shall come into operation on such date as the Minister may, by notice published in the Gazette, appoint. Short title and commencement

2. (1) The Minister may make such regulations as he considers necessary or expedient in the interests of Botswana to control dealings in livestock. Powers of Minister to make regulations to control dealings in livestock

(2) Without prejudice to the generality of the powers conferred by subsection (1), regulations made under this section may —

- (a) provide for the licensing of persons engaged in dealings in livestock;
- (b) provide for a system of permits to control dealings in livestock;
- (c) prescribe fees for or in connexion with licenses or permits which may be issued under the regulations;

- (d) require any person engaged in or connected with dealings in livestock to produce to such person as may be specified in the regulations any books, accounts or other documents in his possession or under his control relating to such dealings; and
  - (e) provide for any incidental or supplementary matters for which the Minister thinks it expedient for the purposes of the regulations to provide.
- (3) In respect of any contravention of regulations made under this section, the regulations may provide that the offender shall be liable —
- (a) for a first offence, to a fine not exceeding P500 or to imprisonment for a term not exceeding one year or to both such fine and imprisonment; or
  - (b) for a second or subsequent offence, to a fine not exceeding P1 000 or to imprisonment for a term not exceeding 2 years or to both such fine and imprisonment.
- (4) Regulations made under this section may be made so as to apply generally or to any particular kind or class of livestock or to any particular area of Botswana specified in the regulations.

3. (1) Where, in any proceedings in respect of the contravention of any regulations made under section 2, direct oral evidence of a fact would be admissible, any statement or entry tending to establish that fact and purporting to have been made in the course of business in any book or other document found in the possession or under the control of an accused person or of his employee or agent shall be admissible in evidence in those proceedings against that accused person without further proof thereof and the court shall presume that the facts stated therein are true unless the contrary is proved.

- (2) Where the employee or agent of any person —
  - (a) contravenes any regulations made under section 2; or
  - (b) does or omits to do anything which would constitute a contravention of such regulations if that thing were done or omitted to be done by his employer or principal,
 the employer or principal shall be deemed, for the purposes of this Act, himself to contravene the regulations unless he proves that he has taken every reasonable step to prevent any contravention, act or omission of the kind in question.

(3) An employer or principal shall be deemed, for the purposes of subsection (2), not to have taken every reasonable step to prevent any contravention, act or omission of the kind in question if the only step he has taken is to issue instructions forbidding such contravention, act or omission by his employee or agent.

(4) where an employer or principal is deemed, by virtue of subsection (2) (a), himself to contravene any regulations made under section 2, he may be prosecuted for that contravention either

alone or jointly with the person who in fact contravenes the regulations.

(5) In this section —

“employee” means a person bound by a contract to work for another person who is entitled, under the contract, to control or supervise the work of the former person;

“employer” means a person for whom another person is bound by a contract to work and whose work the former person is entitled, under the contract, to control or supervise.

4. The Control of Livestock Industry Act is hereby repealed.
