 - "Toyota DA 116; body style 7 ton truck; year of manufacture, 1978; manufacturer's serial No. 23094; engine No. 2D/144/133; registration No. BD 8174"
 - and deliver them to the Applicant/Plaintiff for its duly authorised representative pending decision of an action instituted by plaintiff.
- 2. A Rule Nisi do issue calling upon the Defendant to show cause if any to this Honourable Court on the 10th day of July, 1981 at 10 o'clock in the forenoon or so soon thereafter as the matter may be heard why:-
 - (a) the attachment of the goods as aforementioned should not be confirmed;
 - (b) the Defendant should not be directed to pay the costs of this application;
 - (c) alternative relief should not be granted to the Plaintiff.
- 3. The order be served on Defendant personally and by simultaneous advertising thereof in the Government Gazette and Botswana Daily News.
