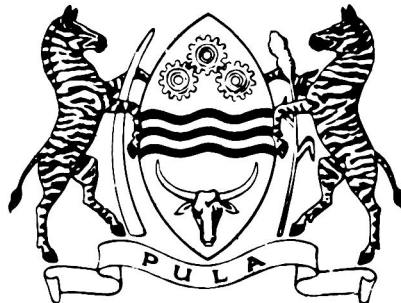

**EMPLOYMENT OF NON-CITIZENS (AMENDMENT) BILL, 1981**

*(Published on 17th July, 1981)*

**MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to correct an error by amending the Employment of Non-Citizens Act, 1981, (Act No. 11 of 1981), in order to give effect to an amendment to the Employment of Non-Citizens Bill, 1981, (Bill No. 4 of 1981), which amendment was passed by the National Assembly at its last meeting.

3. Unfortunately, as finally enacted by Parliament, the Act did not reflect all the terms of the amendment passed by the National Assembly. The only way the error may be corrected is by the enactment of an amending Act.

4. The definition of "non-citizen" contained in the original Bill excluded from the category of non-citizens persons entitled to diplomatic immunity.

5. The amendment to the original Bill passed by the National Assembly was intended, at least in part, to have the opposite effect and include persons entitled to diplomatic immunity in the category of non-citizens for the purposes of the Act.

6. The amendment proposed by this Bill is intended to do the same and thus give effect to the already declared intent of the National Assembly.

1. This Act may be cited as the Employment of Non-Citizens (Amendment) Act, 1981. Short title

2. Section 2 of the Employment of Non-Citizens Act, 1981, is amended by substituting for the definition of "non-citizen", which appears therein, the following new definition — Amendment of section 2 of Act 11 of 1981

"non-citizen" means a person other than —

- (a) a citizen of Botswana; or
- (b) a person or a member of a class of persons declared by the the Minister, by order published in the Gazette, not to be a non-citizen for the purposes of this Act;"
