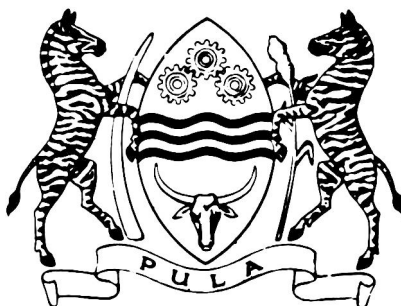

### EXTENSIONS TO MAHALAPYE COMMUNITY JUNIOR SECONDARY SCHOOL AT MAHALAPYE

TENDERS ARE invited for the construction, completion and maintenance of extensions to Mahalapye Community Junior Secondary School comprising a Standard General Science Laboratory Block, a Standard Toilet Block (Water Borne), and associated external works and drainage and, if sufficient funds are available, a Standard Multi-Purpose Block.
