#### Authorization to Discharge Functions of the

#### President

#### TO: THE HONOURABLE MOUTLAKGOLA PALGRAVE KEDIRETSWE NWAKO, M.P., MINISTER OF COMMERCE AND INDUSTRY

WHEREAS it is provided in section 36 (1) of the Constitution of Botswana that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice President, or during the period when the Vice-President is absent from Botswana, some other Minister, to discharge such of the functions of the office of President as he may specify until such authority is revoked;

AND WHEREAS the Vice-President is absent from Botswana;

AND WHEREAS I intend to be absent from Botswana from 6th March, 1982, and consider it desirable to issue directions as aforesaid:

NOW THEREFORE, in exercise of the powers vested in me as aforesaid, I authorize you, the said Moutlakgola Palgrave Kediretswe Nwako, in your capacity as Minister of Commerce and Industry, to discharge, with effect from the said 6th March, 1982, all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint persons to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(d) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution,

until this, my authority, is revoked by me.
