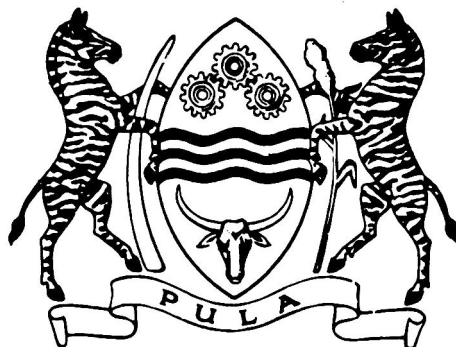

NOTICE IS HEREBY GIVEN, under the provisions of section 17 (1) of the Weights and Measures Act, that all persons having weighing or measuring instruments, weights or measures in use in trade or in their possession or charge for use in trade, within the area specified in the Schedule, are required to produce the same to an Assizer for the purpose of their being assized or re-assized at the place specified and at the appropriate time specified in the Schedule.

NOTICE OF PREQUALIFICATION OF CONTRACTORS

- 1.0 The Government of the Republic of Botswana has received from the Kreditanstalt für Wiederaufbau, West Germany guarantees of financial assistance for the Extensions and Alterations to the Main Depot of the Central Transport Organisation at Gaborone.
- 2.0 The Government of the Republic of Botswana invites interested contractors to submit information for prequalification purposes in connection with the above mentioned Extensions and Alterations as requested in the "Questionnaire for Prequalification of Contractors". The Construction work for above project will be awarded by international competitive bidding according to the regulations of the Central Tender Board of the Republic of Botswana and the requirements of Kreditanstalt für Wiederaufbau.
- 3.0 The project will basically include the following: —
 - 3.1 Construction of new buildings including electrical and mechanical works comprising Workshop, Central Store, Social Amenities building, Reception, Pool Office and sub-station (total plinth area approximately 8825 m²). The workshop and store buildings will be of structural steelwork frames with steel roofing with brickwork or steel sheet side cladding. Social Amenities building, Reception, Pool Office and Sub-station will be of conventional single storey construction.
 - 3.2 Alterations including electrical and mechanical work to existing store and machine shop complex (total plinth area approximately 2340 m²).
 - 3.3 External works comprising roads and parking areas (approximately 8500 m²) and associated stormwater drainage, soil drainage, water supply and fencing.
 - 3.4 The site of the above works is approximately 4 km from Gaborone adjacent to the present airport.
- 4.0 The tender period is scheduled from mid-July to Mid-September 1982.
- 5.0 Prequalification documents may be obtained without cost from the Secretary, Central Tender Board, Private Bag 0058, Gaborone and shall be returned to the same address by registered mail to arrive *not later than 0900 hours on 11th June, 1982*. - 6.0 All contractors participating in the prequalification will be informed of the results of the prequalification. Documents submitted in connection with the prequalification will be treated as confidential. Documents will not be returned.
- 7.0 The particulars of the proposed works given herein are provisional only and must be considered as advance information to assist prospective tenders in deciding whether to apply for prequalification or not. The accuracy of the particulars is not guaranteed and this prequalification notice shall not form part of the contract which may subsequently be entered into by the Government.
- 8.0 Tender documents will only be issued to prospective tenders who have been prequalified. The language of the tender and contract documents will be English and the contractor's senior supervisory staff shall speak, read and write the English Language fluently.
