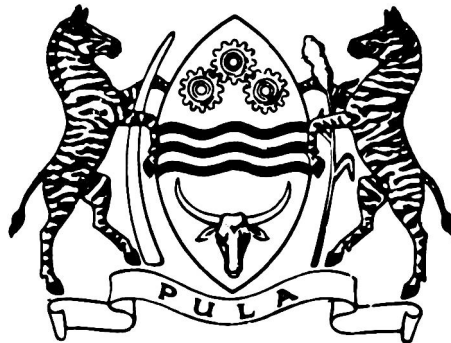

### **Kweneng District Council — Tender No. 10 of 1982**

KWENENG DISTRICT COUNCIL invites tenders for the Kweneng Water Point Survey.

The consultant will collect data on all permanent water sources (approximately 600) north and west from Molepolole on an area of about 24 000 km<sup>2</sup> (63% from Kweneng).

As a result the consultant must produce a map 1:250 000 and several cross referenced lists. The main issue is to locate the water points exactly. No water analyses will be done.

The work should be carried through in 5 months.

A four wheel drive vehicle with fuel, new aerial photographs and materials as well as office space will be provided.

The consultant may include a "guide driver", who should know Kweneng District well, to the tender, but he can also be hired separately. The cost of travel to and from Molepolole at beginning and end must be included in the tendered fee. Accommodation is the consultant's own responsibility and must also be included.

All subsistence costs must be included, too.
