SALES TAX (AMENDMENT) (NO. 2) BILL, 1982

(Published on 19th November, 1982)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to amend the Sales Tax Act to effect a few minor amendments as stated below.

3. Section 4 of the Act provides that the value of the sale of any goods shall be the sum of all the amounts of the consideration accruing to the seller in respect of the sale. Clause 2 of the Bill provides that where there is any dispute or doubt as to the consideration accruing to a seller, then, the value shall be taken to be the price which the goods whould fetch on sale in the open market.

4. Clause 3 seeks to amend section 5 of the Act to provide that an importer may apply to the Minister for an extension of time within which to pay the tax on goods imported or to be imported. If the Minister considers such a request reasonable he may direct the Director to allow the importer to pay the tax at the end of the month next succeeding the month in which the goods were imported.

5. Clause 4 provides that sales tax shall not be levied on the sale of goods which are exported from Botswana within 12 months after the date of the sale. The clause also gives the Minister power to make regulations, on the advice of the Director of Customs and Excise, for remitting or repaying the whole or part of the tax payable on goods imported into Botswana for re-export from Botswana.

- 1. This Act may be cited as the Sales Tax (Amendment) Act, 1982, and shall be deemed to have come into operation on 30th August, 1982.
- 2. Section 4 of the Sales Tax (hereinafter referred to as the "the principal Act") is hereby amended by substituting for paragraph (a) thereof, the following new paragraph —

(a) in the case of any sale of goods, the sum of all the amounts of the consideration accruing to the seller in respect of such sale:

Provided that where there is any dispute or doubt as to consideration accruing to the seller, the price which in the opinion of the Director the goods would fetch, on a sale made at the time when the tax in respect of the goods becomes due by a person selling such goods in the open market in Botswana to a retail trader carrying on business in Botswana;".

Amendment of section 5 of principal Act

- **3.** Section 5 of the principal Act is hereby amended by adding immediately after subsection (3) thereof, the following new subsection —
- "(4) Notwithstanding the provisions of subsection (3), the Minister may, on application made by an importer for an extension of time within which to pay the tax due on any goods imported or to be imported, direct the Director, if he considers such application reasonable, to allow the importer to pay the tax at the end of the month next succeeding the month in which the goods were imported.".

Insertion of sections 14E and 14F in principal Act

4. The principal Act is hereby amended by inserting immediately after section 14D, the following new sections —

principal Act "Relief from tax on exportation of goods 14E. Tax shall not be levied on the sale of goods liable to tax if such goods are exported from Botswana within a period of 12 month after the date of such sale.

Relief from tax on importation of goods 14F. The Minister, on the advice of the Director, may by regulations make provisions for remitting or repaying the whole or part of the tax payable on the importation of any goods if the Director is satisfied that the goods have been or are to be re-exported."
