COMPANIES (AMENDMENT) BILL, 1982

(Published on 3rd December, 1982)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Section 124 (1) of the Companies Act (Cap. 42:01) provides that a person shall not be qualified to be appointed as an auditor of a company unless either

(a) he is a member of a body of accountants established in the United Kingdom and for the time being recognized by the Board of Trade for the purposes of the qualification of auditors of companies incorporated in the United Kingdom or of a body of accountants established by statute in South Africa, Zambia, Malawi or Zimbabwe; or

(b) he is for the time being authorized by the Minister to be so appointed as having adequate alternative qualifications or as having obtained adequate knowldge and experience in the course of employment under articles.

3. The object of the Bill is to amend section 124(1) of the Companies Act in order to include among persons qualified to be appointed as an auditor of a company a member of a body of accountants established by statute in any part of the Commonwealth or in any country outside the Commonwealth designated by the responsible Minister.

1. This Act may be cited as the Companies (Amendment) Act, 1982, and shall come into operation on such date as the Minister may, by notice published in the Gazette, appoint.

2. Section 124 (1) of the Companies Act is amended by substituting for paragraph (a) thereof the following new paragraph —

"(a) he is a member of a body of accountants —

(i) established by statute in any part of the Commonwealth;

(ii) established by statute in any country outside the Commonwealth designated by the Minister, by notice published in the Gazette, for the purposes of this pragraph; or

(iii) established in the United Kingdom and for the time being recognized by the Department of Trade and Industry for the purposes of the qualification of auditors of companies incorporated in the United Kingdom; or".
