

## BIRTHS AND DEATHS REGISTRATION (AMENDMENT) BILL, 1983

(Published on 4th March, 1983)

### MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Under the existing law, the Registrar of Births and Deaths is prohibited from issuing a death certificate in respect of a deceased person whose death is a subject of an inquiry under the Inquests Act (Cap. 07:01) or under the Mines, Quarries, Works and Machinery Act (Cap. 44:02) until such time as the inquiry is completed and a report is made to him stating the cause of death. An inquiry is required to be held in respect of any person who died a violent or other unnatural death. In some cases it takes weeks before an inquiry is completed. Protracted inquiry may cause a great deal of incovenience to a bereaved family where the body is to be conveyed out of the country for burial.

3. The object of the Bill is therefore to amend section 25 of the Births and Deaths Registration Act to enable the Registrar of Births and Deaths to issue death certificates in cases where a medical practitioner has performed a post-mortem examination of the body or has examined the body and issued a

certificate stating the cause of death.

Amendment of section 25 of Cap. 30:01

- 2. Section 25 of the Births and Deaths Registration Act is hereby amended by adding immediately after subsection (2) thereof, the following new subsection
  - "(3) Notwithstanding the preceding provisions of this section, the District Registrar may, in such special circumstances as may be prescribed, record the cause of death before any investigation, report, inquest or inquiry referred to in subsection (1) is made or held, if a certificate of the cause of death is issued by a medical practitioner —
  - (a) who performed a post-mortem examination of the body; or
  - (b) who has examined the body:

Provided that where the cause of death subsequently reported to the District Registrar at the conclusion of an enquest or inquiry under subsection (2) differs from that contained in the certificate issued by a medical practitioner under this subsection, the District Registrar shall amend his record by substituting the report of the inquest or inquiry for the certificate issued by the medical practitioner.".
