Notice of Defaulting Occupiers

IT IS HEREBY NOTIFIED, in performance of the duty imposed by regulation 6 of the Regulations, that there is owed by and due from each of the persons named in the first column of the Schedule, being the holder of a Certificate of Rights in respect of the Plot of State Land situated within the Lobatse Township the number of which is specified in the corresponding entry in the second column of the Schedule, the amount specified in the corresponding entry in the third column of the Schedule, which amount represents the amount owed by and due from him or her of the service levy imposed on him or her, as the occupier of the said Plot, by the Lobatse Town Council under section 4A of the Act, and the amount specified in the corresponding entry in the fourth column of the Schedule, which amount respresents the amount owed by and due from him or her of instalments towards repayment of a Building Material Loan granted him or her, as occupier of the said Plot, by the Lobatse Town Council under section 4C of the Act.

Bill No. 12 of 1983

LOCAL GOVERMENT (DISTRICT COUNCILS) (AMENDMENT) BILL, 1983

(Published on 27th May, 1983)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The principal object of the Bill is to amend the Local Government (District Councils) Act (Cap. 40:01) in order to make the law governing the manner in which District Councils are required to enter into certain contracts more flexible.

3. Section 39 of the principal Act at present provides that a District Council shall not enter into certain contracts if the Council's liability under the contract is to exceed P1 000, except after calling for tenders in the prescribed manner.

4. The contracts in question are contracts for the supply of any goods or materials or the execution of any works or the provision of any services, other than professional services, for or to a Council.

5. It is proposed to substitute a new section 39 of the principal Act simply forbidding a District Council to enter into such a contract except in the prescribed manner.

6. At the same time, it is proposed to amend section 56 of the principal Act so that the President's powers to make regulations would be given instead to Minister for the time being responsible for local government.

Amendment of section 56 of principal Act 3. Section 56 (1) of the principal Act is amended by substituting for the word "President", which appears therein, the word "Minister".
