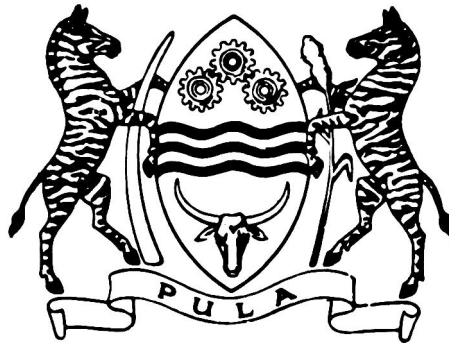

Income Tax Returns Tax Year Ending 30th June, 1983

IN ACCORDANCE with section 64 (2) of the Income Tax Act, notice is hereby given that every person liable to furnish a tax return *for the tax year ending 30th June, 1983*, is required to furnish such return to me in the prescribed form within 2 months of the end of that tax year.

2. Persons required to furnish a tax return are —

- (a) every person liable to pay tax,
- (b) every partnership;
- (c) every employee or other individual whose chargeable income exceeds the annual rate of P1 200 during the tax year;
- (d) every trustee of a person under a legal disability or executor of the estate of a deceased person where the chargeable income of that trust or estate exceeds the annual rate of P1 200 during the tax year;
- (e) every company, every trustee of a trust or of an insolvent estate and every non-resident to whom any chargeable income has accrued during the tax year,
- (f) every person whom in any previous tax year has made a loss in respect of which he may be entitled to claim a deduction in the tax year or any subsequent tax year; and
- (g) every person who was liable to pay tax in respect of the previous tax year,

except such persons who have been advised in writing by the Commissioner that a return is not required for the tax year and any non-resident whose only income for the tax year was subject to and has been subjected to deduction under the provisions of section 58 of the Act.

- (b) Income Tax Assessment Office, Private Bag 38, Francistown,
- (c) Income Tax Assessment Office, Private Bag 7, Serowe,

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. There has been of late an increase in illegal dealings in habit-forming drugs, especially the drug known as Mandrax.

3. The object of the Bill is to amend the Habit-Forming Drugs Act by increasing the penalty for illegal dealings or use of such drugs.

4. Clause 2 of the Bill therefore proposes that any person convicted of, illegal dealings in, or being in possession of, habit-forming drugs, other than dagga, shall be liable in the case of a dealer to a minimum term of imprisonment of not less than 2 years but not more than 15 years and a fine of P15000 and in default of payment of the fine, the convicted person shall be liable to an additional term of imprisonment of not less than 3 years but not more than 5 years and in the case of a person using or found in possession of such drug, to a fine of not less than P1500 but not more than P5000 and in default of payment of the fine to a term of imprisonment of not less than one year but not more than 5 years.

Provided that the total terms of imprisonment imposed under this paragraph shall not exceed 15 years; or

- (b) in the case of a contravention of the provisions of subsection (1) (b), to a fine of not less than P1 500 but not more than P5 000 and in default of payment of such fine, to a term of imprisonment of not less than one year but not more than 5 years:

Provided that if the contravention of which a person is convicted under subsection (1) relates only to dagga such person shall be liable for the penalty specified in section 9.

INCOME TAX (AMENDMENT) BILL, 1983

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The main objects of the Bill are, to reduce the rate of tax exigible in relation to individuals, to alter the standard value specified in the Table to paragraph 3 of Part II of the First Schedule to the Income Tax Act in valuing stock and also to effect a few minor amendments to the Income Tax Act.

3. Clause 2 amends section 5 by removing the requirement that the Governor of the Bank of Botswana or his representative should make an oath or a declaration of secrecy. Such an oath would prevent the Governor from using vital information received in connexion with tax matters in investigating any irregularities in respect of the Exchange Control Act and regulations made thereunder.

4. Clause 3 proposes to amend section 10 by imposing a tax on capital grants from the Productive Employment Fund and specifies the date on which such tax becomes payable.

5. Clause 4 proposes to amend section 22 to make it clear that a partner is not entitled to set off his assessed loss of the partnership against any amount accruing to him in any tax year from any source outside the partnership.

6. Clause 5 amends section 28 (2) by including in gross income of any person any business debt waived or released by a creditor of such person.

7. Clause 6 amends section 31 (3) which relates to taxation of housing benefits by providing a new method of calculating the value of any quarters or residence provided for any employee by an employer.

8. Clause 7 seeks to amend section 34 (1) to include in gross income the proceeds from the disposal of a residential property which is not a principal private residence.

9. Clause 8 amends section 39 regarding deductions allowed for management and consultancy fees in ascertaining chargeable income.

10. Clause 9 amends section 54 (3) to clarify the point that the person entitled to tax exemption is a person who is not a citizen but resident in the country.

11. Clause 10 seeks to clarify the provisions relating to the granting of relief in calculating chargeable income accruing to any person from the disposal of property under the Twelfth Schedule.

12. Clause 11 seeks to amend section 110B to modify the method of estimating tax payable by a designated company.

13. Clause 12 amends section 113 to impose a penalty for default by a company in paying the instalment of the estimated tax on the unpaid amount of the instalment.

14. Clauses 13 and 14 amend Part II of the First Schedule to prescribe new standard values for valuing livestock.

15. Clauses 15 and 16 seek to effect minor amendments for purposes of clarity.

16. Clause 17 contains the reduced rate of tax exigible in relation to individuals.
