(S.I. 137 of 1982)

(regulation 6)

Notice of Defaulting Occupiers

IT IS HEREBY NOTIFIED, in performance of the duty imposed by regulation 6 of the Regulations, that there is owed by and due from each of the persons named in the first column of the Schedule, being the holder of a Certificate of Rights in respect of the Plot of State Land situated within the Gaborone Township the number of which is specified in the corresponding entry in the second column of the Schedule, the amount specified in the corresponding entry in the third column of the Schedule, which amount represents the amount owed by and due from him or her of the service levy imposed on him or her, as the occupier of the said Plot, by the Gaborone Town Council under section 4A of the Act, and the amount specified in the corresponding entry in the fourth column of the Schedule, which amount represents the amount owed by an due from him or her of instalments towards repayment of a Building Material Loan granted him or her, as occupier of the said Plot, by the Gaborone Town Council under section 4C of the Act.
