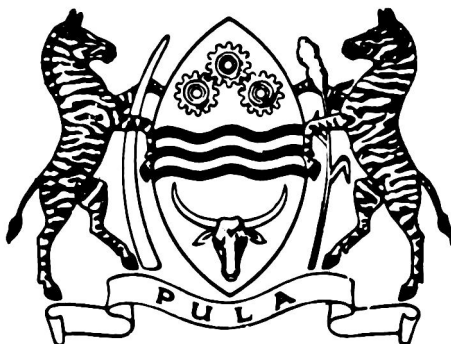

REQUEST FOR DISPLAY OF INTEREST GABORONE WATER AUGMENTATION SCHEME: PHASE I — CONSTRUCTION

DISPLAYS of interest are invited from contractors, registered with Central Tender Board in the category Class 5 — Grade E (unlimited), interested in tendering for the construction of Gaborone Water Augmentation Scheme — Phase I.

The project comprises the laying of approximately 9 kilometers of 400 mm diameter ductile iron pipeline including all specials and valves from Ramotswa Junction and approximately 22 kilometers of 500 mm diameter ductile iron pipeline including all specials and valves from Bojanjwe Hill to the Gaborone Treatment Works.
