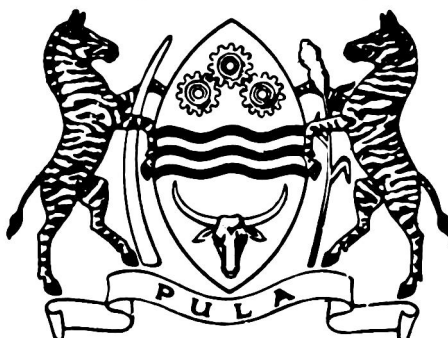

STATE LAND (PROCEDURE FOR ENFORCEMENT OF PAYMENT OF LEVIES  
AND LOANS) REGULATIONS, 1982

(S.I. 137 of 1982)

(regulation 6)

## Notice of Defaulting Occupiers
