Short title

1. This Act may be cited as the Gaborone Dam Wall Raising and Associated Water Works Loan (Authorization) Bill, 1983.

Authorization to raise loan 2. The Minister may raise by loan from the OPEC Fund for International Development (in this Act referred to as the "Fund"), subject to such terms and conditions as may be agreed between the Minister and the Fund, sums not exceeding in the aggregate U.S. \$2 million.

Loan to be paid into Development Fund

(in this Act referred to as "the loan") shall be paid into the Development Fund.4. All sums required to repay the loan and to pay the interest

3. The proceeds of the loan authorized to be raised by this Act

Loan charged upon Consolidated Fund Powers of Minister in connextion

with loan

and other charges thereon shall be charged upon and paid out of the Consolidated Fund.

Report on loan to be laid before National Assembly 5. The Minister is hereby empowered to sign on behalf of the Government and to authorize any public officer so to sign any agreements embodying the terms and conditions of the loan and to do all such things as may be necessary or expedient to effect or facilitate the loan or such agreements.

6. As soon as practicable after the raising of the loan, the Minister shall lay before the National Assembly a paper containing a report on the loan which shall include the terms and conditions of the loan and any other information relating thereto which the Minister considers appropriate to include.
