CONSTITUTION OF BOTSWANA

Authorization to Discharge Functions of the President

TO: THE HONOURABLE PETER SIMAKO MMUSI, VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorizations, as the case may be;

AND WHEREAS I intent to be absent from Botswana from 17th July to 23rd July, 1985, and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, PETER SIMAKO MMUSI in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 17th July to 23rd July, 1985, all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me, whichever happens first.
