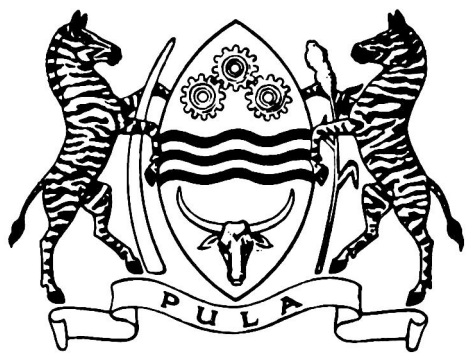

IN EXERCISE of the powers conferred on the Local Government Election Supervisor by regulation 5 (5) of the Local Councils (Conduct of Elections) Regulations, notice is hereby given that the Minister of Local Government and Lands has issued an election instrument to the returning officer of the Ntloedibe Polling District directing him to receive nominations of candidates for a bye-election to be held at the said polling district and that such nominations to be received between the hours of 9.00 a.m. and 1.00 p.m. and between 2.30 p.m. and 5.30 p.m. at the District Commissioner's Office, Molepolole on 9th August, 1985. The said instrument further directs that any poll which may be necessary shall be held on 31st August, 1985.
