

#### Authorization to Discharge Functions of Office of President

# THE HON MOUTLAKGOLA PALGRAVE KEDIRETSWE NWAKO, M.P., MINISTER OF COMMERCE AND INDUSTRY

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President or in the absence of the Vice-President, a Minister, to discharge such of the functions of the office of President as he may specify and the person so authorised may discharge those functions until the revocation of such authorization:

AND WHEREAS the Vice-President is out of the country on official duties;

AND WHEREAS I intend to be absent from Botswana from 12th October, 1985, and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, MOUTLAKGOLA PALGRAVE KEDIRETSWE NWAKO in your capacity as Minister of Commerce and Industry to discharge with effect from 12th October, 1985 until the return to Botswana of the Vice-President, all the functions of the office of President, except, —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until the return of the Vice-President to Botswana or this authority is revoked by me, whichever happens first.

#### CONSTITUTION OF BOTSWANA

#### Authorization to Discharge Functions of Office of President

TO: THE HON PETER SIMAKO MMUSI, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from 12th October, 1985, and I consider it desirable to issue directions as aforesaid:

AND WHEREAS at the time of my departure from Botswana you were out of the country on official duties and I have therefore directed the Hon MOUTLAKGOLA PALGRAVE KEDIRETSWE NWAKO to discharge the functions of office of the President until your return to Botswana;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, PETER SIMAKO MMUSI in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge immediately on your return to Botswana, all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me, whichever happens first.
