

#### CONSTITUTION OF BOTSWANA

#### Authorization to Discharge Functions of Office of President

TO: THE HON PETER SIMAKO MMUSI, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify and the Vice-President may dishcarge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from 13th November, 1985, and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, PETER SIMAKO MMUSI in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 13th November, 1985, all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my to return Botswana or this authority is revoked by me, whichever happens first.

# BUILDING SOCIETIES (AMENDMENT) BILL, 1985

(Published on 22nd November, 1985)

# **MEMORANDUM** ·

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Under the existing provisions of the Building Societies Act, a building society can only lend money or make advances on the security of urban immovable properties. The definition of urban immovable property does not cover land held under a certificate of rights. Consequently the holders of land under certificate of rights are denied the opportunity of raising loans by utilising their land as securities. This is because, as the Presidential Commission on Land Tenure found, land held under certificate of rights did not provide adequate security for the grant of loans. And this was due to the fact that the Town Council's prior consent was required for any sale in execution of land held under certificate of rights. As stated at page 19 of the Report of the Presidential Commission on Land Tenure:

"SHHA has introduced the necessary procedures for the Town Councils when it agrees to the hypothecation, to give prior consent to sale in execution to any interested citizen purchaser. On this basis the Botswana Building Society has indicated its willingness to lend against COR provided the Building Socieities Act is amended to permit it to do so."

The Commission accordingly recommended that the Building Societies Act should be amended and the recommendation has been accepted by the Government.

3. The main object of the Bill is therefore to give effect to the recommendations of the Presidential Commission on Land Tenure as approved by the National Assembly on 19th April, 1985.

4. Consequently clause 2 of the Bill provides for the amendment of sections 2, 3 and 17 (1) by deleting all references in the Act to the word "urban" in qualifying immovable property.
