

BOTSWANA MEAT COMMISSION (AMENDMENT) BILL, 1985 (Published on 29th November, 1985)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The Botswana meat Commission Act was enacted in 1965 by Law 22 of 1965. Although there have been subsequent amendments to the Act, there are certain provisions of the Act which are considered to be out of date.

3. The main object of the Bill is, therefore, to amend the Act to update it by bringing it in line with the actual day to day practice of the Commission.

4. Clause 2 proposes an amendment to section 2 of the Act by defining the word Chairman to mean the Executive Chairman which is infact the case currently pertaining in the Commission. Similarly the financial year is being changed from the period of twelve months ending on 31st December to a period of twelve months ending on 30th September.

5. Most of the functions which are conferred on the President under the Act are now invariably being performed by the Minister. Consequently it is considered necessary to amend the Act to reflect the true position of administering the provisions of the Act. Thus clause 3 provides that the powers conferred on the President by section 4, 6, 9, 10, 12 and 21 should be delegated to the Minister. This delegation, however, does not affect the power of the President to appoint the members of the Commission including the Executive Chairman.

6. Clause 4 proposes to amend section 9(4)(b) by increasing the outlay on capital account to P500,000.

7. Clause 5 amends section 15 of the Act by substituting the words "Stabilization Reserve" for the words "Stabilization Fund" as the latter words have given rise to some confusion. The clause also proposes that the Stabilization Reserve should be increased to P15 million.

8. Clause 6 amends section 16 to increase the development reserve from P1 for every head of cattle purchased by the Commission to P2.

9. Clause 7 proposes that the restriction in respect of export of cattle from Botswana except with the permission of the Minister should include product from cattle.

10. Clause 8 amends paragraph 2 of the Schedule by providing that the Chairman of the Commission shall be an Executive Chairman. The remaining amendments proposed by the clause have been necessitated by the designation of the Chairman as an Executive Chairman.

The Executive Chairman appointed under paragraph 2 (1) "Executive shall be the chief executive officer of the Commission and shall, subject to the instructions of the Commission, manage the undertakings, operations, property of the Commission and exercise such of the powers of the Commission as the Commission may from time to time delegate to him.

10. The Commission shall, subject to the provisions of this Officers, Act, appoint such officers, servants and agents as it may deem servants and necessary for the proper discharge of its functions under this Act on such terms and conditions as it may determine.

11. (1) The Commission may, with the approval of the Pensions etc. Minister, make provision for the payment on the death, injury or retirement of any of its officers, servants or agents of pensions, gratuities or like benefits to them or to others by reference to their servicde or otherwise
