Each unit of an articulated vehicle is rated as insured separately in respect of the tractor unit under group reference 8, and in respect of the semi-trailer unit according to the purpose for which such unit is designed or used, i.e. under group 2A, 2B, 2C, 2D, 3A, 3B, 3C, or 3D, as the case may be.

(5) Station wagons and similar type vehicles, if used for the carrying of trade goods, must be rated under group reference 2A, 2B or 2C.
