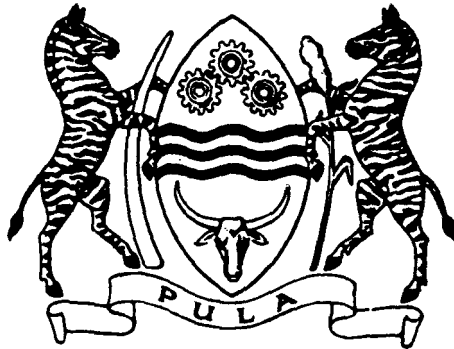

MINISTER OF FINANCE AND DEVELOPMENT PLANNING**

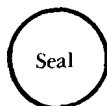
